ASSOCIATION OPEN TOURNAMENT RULES

1 Each entrant in this Tournament must be a member of the Lancaster USBC Association. Only 2 professional entrants per 4 person team, 1 entrant per doubles team.

2 Tournament is both scratch and handicap – equal payouts in each – handicap is 100% based on 230. An entry may only cash in one division per event, depending on highest payout.

3 A bowler may compete on multiple teams in the team event by replacing 2 people, in doubles by replacing 1 person. Any bowler bowling multiple times in singles event may only cash once. A bowler's first appearance counts toward all events score. A bowler who desires to enter Minor Events only must enter both the Doubles and Singles events. If your partner is late, you will bowl singles first.

4 Entrants will use their highest USBC league average for the previous season based on a minimum of 21 games (summer leagues if no winter league). If no previous average, use average as of 10/19/2026 minimum 12 games. All others use 230 avg.

5 Prize winnings for the previous 12 months need not be reported.

6 Qualified substitutes may be used, but a substitute must bowl each event under his own name, and then only at the scheduled time in each event in which he is a substitute bowler. A substitute is not required to reimburse the original entrant nor share any prize money that may have been won.

7 Transfer of All-Events may be made provided the transfer is made before the original entrant or the transferee has bowled in any of the tournament events.

8 Walk ins will be accepted only if lanes are available and a completed entry and full payment is made ½ hour before the scheduled squad time.

9 Lane assignments for each event shall be scheduled by the Tournament Director in the order they are received.

10 All three games of each event will be bowled on the same pair of lanes.

11 The prize fund will be returned 100 % in cash and championship awards. At least one prize for each 5 entries will be awarded in each event. Championship plaques will be awarded to champions in each event. If the score qualifies in both scratch and handicap, prize of greater value is awarded. If score qualifies for same value, scratch prize will be awarded.

12 Teams and individuals must report to the Tournament Director at least 30 minutes prior to their scheduled starting time. Any bowler who arrives late shall begin play and score to count from the frame then being bowled by the other bowlers on the pair of lanes.

13 Alcoholic beverages may not be brought in to the lanes hosting the tournament.

14 The Board of Directors has designated the Tournament Director to act in its stead during the Tournament, and any questions arising which are not provided for in these rules shall be decided by the Tournament Director with the approval of the Board. All protests effecting eligibility or general playing rules must be confirmed in writing to the Tournament Director before the tournament prizes are awarded. Errors in scoring must be reported to the Tournament Director within 24 hours.

15 All rules not covered by the above will revert to USBC rules.

Failure to appear will result in forfeiture of all entry fees and prize money.
